MARINA DEL REY, CA ----May 23, 2013 ---- The Internet Corporation for Assigned Names and Numbers (ICANN) Board of Directors has recently approved the proposal submitted by the Arab Center for Dispute "I thoroughly believe in the Resolution (ACDR) to be an

service provider for the Uniform Domain Name Dispute Resolution Policy (UDRP). The Center will start operating in January 2014.

The ACDR is jointly established by the Arab Intellectual **Property** Mediation and Arbitration Society (AIPMAS) and the Arab Society for Intellectual Property (ASIP), headquarters in Amman, Jordan and offices in other Arab countries. It is the first UDRP provider in the Middle East and Northern Africa and importance of arbitration official dispute resolution it owns a vast experience

in resolving Intellectual Property disputes.

HE Dr. Talal Abu-Ghazaleh, AIPMAS chairman expressed his satisfaction with ICANN's recognition. He is confident the Center will serve the entire region in discharging its' functions.

Earlier, the AIPMAS General Assembly unanimously agreed to establish Arab Center for Dispute Resolution (ACDR). Talal Abu-Ghazaleh Legal, member of Talal Abu-Organization Ghazaleh was entrusted to make the operational Center fully under the auspices of the Arab Intellectual Property Mediation and Arbitration Society (AIPMAS).

Dr. Abu-Ghazaleh said that as the fifth accredited center in the world, and being in the Arab region, the Center has particular significance for focusing on domain namerelated disputes capable of being settled by arbitrators proficient in many languages.

at Law, who will deal solely with resolving IP domain name disputes and will provide reliable and quality administration of UDRP cases in three major languages - Arabic, English and French with more in the near future.

A graduate from Temple University Law School Philadelphia, PA, Ms. Khan has a long experience in this field and is a member of the New York Bar Association; she is fluent in English, French, Spanish, Urdu and Dari and has worked as a Human Rights Legal Affairs Officer, legal advisor and consultant.

The Center is inviting attorneys, academics and all those who are interested in joining the Panelists to contact the Center and be part of this official dispute resolution service provider.

The Arab Intellectual Property, Mediation and Arbitration Society (AIPMAS), is a non-profit organization, headed by HE Dr. Talal Abu- Ghazaleh. It was established in Amman


## TM Applications Filed Prior to July 7, 2006 in Ethiopia Should be "Re-Registered

ADDISABABA-The Ethiopian Registry Office announced that trademark applications filed prior to July 7, 2006 should be "re-registered" under the new law to be effective in Ethiopia. The deadline to complete this process is June 18, 2014.

Ethiopia brought some changes to the Trademark Legislation which came into effect in Ethiopia at the end of 2012. The new regulations were published in Ethiopia on December 24, 2012, bringing into force the Trade Mark Registration and Protection Proclamation 2006.

## Kingdom of Saudi Arabia to Accede to WIPO's PLT & PCT



GENEVA - The Director General of the World Intellectual Property Organization (WIPO) notified the Minister for Foreign Affairs the deposit by the Government of the Kingdom of Saudi Arabia, on May 3, 2013, of its instrument of accession to the Patent Law Treaty (PLT), adopted in Geneva, on June 1, 2000, and the KSA's deposit of its instrument of accession to the Patent Cooperation Treaty (PCT), signed in Washington on June 19, 1970, amended on September 28, 1979, modified on February 3, 1984, and on October 3, 2001.

According to WIPO, the PLT will enter into force,

with respect to the Kingdom of Saudi Arabia, on August 3, 2013, while the PCT will enter into force on August 3, 2013.

The PLT is designed to streamline and harmonize formal requirements set by national or regional Patent Offices for the filing of national or regional patent applications, the maintenance of patents and certain additional requirements related to patents or patent applications, such as communications, representation or recordation of changes.

The PCT makes it possible to seek patent protection for an invention simultaneously in each of a large number of countries by filing an "international" patent application. Such an application may be filed by anyone who is a national or resident of a Contracting State. In general, it may be filed with the national patent office of the Contracting State of which the applicant is a national or resident or, at the applicant's option, with the International Bureau of WIPO in Geneva.

## Moroccan Parliament votes on international conventions on IP, ICT and Genetics

CASABLANCA – Due to speedy developments in the field of Intellectual Property in Morocco, the House of Representatives in Morocco's Parliament has recently voted on some important international conventions related to Intellectual Property, Information and Communication Technology and Genetics.

Joining this kind of convention is expected to benefit the Moroccan market and economy. Adopting these conventions would provide Intellectual Property Rights (IPRs) protection on a worldwide basis.

The following is a list of the adopted conventions:

- Agreement concerning the International Registration of Industrial Designs
- Strasbourg Agreement concerning the International Patent Classification
- Singapore Treaty on the Law of Trademarks
- Arab Convention on Combating Information Technology Offences

Moreover, a draft of decree shall be submitted soon before the Moroccan Parliament for establishing the Moroccan National Committee on Innovation and Industrial Research.

## **New Copyright Act Issued in Sudan**



KHARTOUM – Pursuant to the provisions of the Transitional Act No. 2005, Sudan's President Omar Hassan Al-Bashir issued new Act for Protection of Copyrights, Neighboring Rights and Literary and Artistic Works No. 2013. The new Act enters into force as of the date of its signature.

The new Act repeals the Act for Protection of Copyright and Neighboring Rights of 1996 and the Literary and Artistic Act of 2001.

The most important provision of the new Act is the establishment of "Council for Protection of Copyrights, Neighboring Rights and Literary and Artistic Works" that will serve as the advisory body in the country pertaining to copyrights, related rights and literary and artistic works.

According to the Act, the Council is responsible for setting the general policies, plans and programs that organize and promote innovation, creativity and publication in the field of culture.

The new Act allows the Secretary General of the Council to cease the copyright in case of violating the provisions of the Act. The necessary legal penalties shall apply whether imprisonment or fine.

## **Latest USTR Special 301 Report Shows Need for Concerted Action** on Piracy in Key Markets

WASHINGTON DC - The Software Alliance welcomed in a press release the US Trade Representative (USTR)'s annual Special 301 Report, which highlights international markets with the worst track records protecting Intellectual Property and providing market access for rights holders.

"Some of the world's fastestgrowing economies continue to be havens for piracy," said Jodie Kelley, BSA Senior Vice President for Anti-Piracy and General Counsel. "This year's Special 301 report shows that countries like China, India and Russia are making slow progress but still have a long way to go in tackling software piracy. What also stands out in the report is a country like Ukraine, where the piracy rate is not just unacceptably high but also appears to be locked in place."

"Piracy in China continues to be an overriding concern for the software industry because of the sheer scale of China's market," Kelley said. "BSA's research shows that 14 percent of all software piracy

in the world occurs there. The Special 301 Report is important because it highlights opportunities to start bringing the problem under control—for example, by focusing attention on software piracy in China's state-owned enterprises. The report also calls out market barriers that lock foreign-made software products out the Chinese market."

Ukraine's classification as a Priority Foreign Country (PFC) — the most serious designation in the Special 301 Report — is notable because it gives USTR 30 days to decide whether to launch a formal investigation that could lead to trade sanctions.

"Piracy is rampant in Ukraine. It is common even in agencies of government — and authorities are allowing it to spread unchecked online," said Kelley. "BSA and its members stand ready to work with the Ukrainian government to combat software piracy. The best place to start would be a credible program to make sure the government itself is using legal software."

"BSA commends USTR and others in the Administration for their hard work in compiling this important report," said Kelley. "It sends a

strong message that software piracy and other forms of IP theft are in no one's best interests. Improving intellectual property protection would benefit not just foreign right holders but also local innovative industries."
