New VAT Comes in Force in Egypt

CAIRO – The Egyptian Ministry of Finance announced that the Value Added Tax (VAT) law has been officially implemented in the country starting September 9, 2016.

In virtue of this new law, a VAT rate of 10% will be imposed in 2016-17 fiscal year for professional and consulting services.

Accordingly, Abu-Ghazaleh Intellectual Property (AGIP) will add the new VAT amount to all of its Intellectual Property services offered in Egypt.



CAIRO- The Egyptian Cabinet has recently approved the Decision No (344) for 2016 which ratifies the agreement on double taxation on income between Egypt and Bahrain. The bilateral agreement originally signed on April 8, 2016 aims at avoiding double taxation on income between the two countries and preventing income tax evasion.

Egypt has included under the agreement taxes imposed on the income of natural persons, including income from wages and salaries, commercial and industrial activities, and other sources of income as stipulated by the law.

The provisions of the law include also any taxes similar in core to those stipulated by any of the contracting parties' legislations after the signing of this agreement.





15 Successful Candidates Have Been Selected for NextGen@ICANN57

LOS ANGELES - 15 individuals from various universities in the Asian Pacific Region have been selected to participate with ICANN Community Members at the ICANN57 Meeting in Hyderabad India, November 3-9, 2016. According to ICANN, these individuals are engaged in studies that encompass policy, business, technical, security, law, and communications. Five additional selectees who attended a previous ICANN Meeting as NextGenners will now serve as Ambassadors for these newcomers to ICANN.

Individuals assessed were by an independent Selection Committee after submitting an online application and meeting the initial Program requirements. The successful candidates were selected based on their current studies and interest in the work happening in the Internet Ecosystem related to global policy and Internet Governance. They must commit to engage with and learn from the ICANN Community over the Meeting week as well as produce a 10-15 minute presentation related to the work of ICANN and their studies.

Four IP-Related Administrative Instructions Enterinto Forcein Kosovo, IPO Changes Official Fees

PRISTINA- Four new IP-related administrative instructions have recently entered into force in Kosovo.

The Administrative Instruction (AI) No. 08/2016, effective as of July 4, 2016, relates to the accelerated examination of trademark applications, which is still available if there has been an alleged infringement of trademark rights. When requesting such examination, the applicant must indicate the trademark filing details and submit:

- Copy of the trademark application as filed;
- Arguments proving the alleged trademark infringement; and
- Proof of payment of the official fee per trademark in the amount of EUR 120.
- Previously, the applicant also had to submit a proof that a civil or a customs action had been initiated.

The accelerated examination request may be submitted at any time after the filing date, as no time frame is specified. The IP Agency will decide on the request within 15 days from the filing date of the request.

The second AI, No. 10/2016, effective as of August 2, 2016, introduces a single fee system and amends certain official fees.

Previously, the Kosovo IPO provided two different schedules of fees, one for legal entities and one for natural persons. The new AI provides for a single fee schedule for both categories of applicants.

Certain official fees have increased significantly. For instance, the fee for filing oppositions has doubled, from EUR 50 to EUR 100, while the fee for invalidation actions increased from EUR 50 to EUR 200.

The third AI, No. 11/2016, effective as of August 12, 2016, was approved following the entry into force of the new law on geographical indications and designations of origin, in January 2016.

Finally, the fourth AI, No. 12/2016, on the industrial design registration procedure entered into force on August 22, 2016, providing detailed information on the procedures prescribed by the new law on industrial design, in force as of January 2016.

These two AIs thoroughly describe the procedures such as application, registration, publication, recordal of changes, renewal and termination of validity for GI(s) and industrial designs. The new AIs on trademark and patent registration procedures are expected to enter into force soon.
